Sub.: Rejection of Bid and Banning of Business Dealing with M/s ARG TECHNOCRATS.

Ref: - i) EOI No. TCIL/Emp-Arch/EOI/21-22/01 dated 19.01.2022 for "Empanelment of Consultancy firms for Comprehensive Architectural & Civil Engineering Services for a period of three (03) years.

- ii) Your bid dated 17.02.2022
- iii) Show cause notice no. TCIL/Civil/Architect-Emp/Banning/01 dated 20.12.2022
- iv) Your reply via mail dated 21.12.2022 at 5.33 PM.

Dear Sir,

Whereas TCIL had floated an EOI no. TCIL/Emp-Arch/EOI/21-22/01 dated 19.01.2022 for "Empanelment of Consultancy firms for Comprehensive Architectural & Civil Engineering Services for a period of three (03) years.

Whereas it come to notice of TCIL that you had submitted forged experience certificate.

Whereas TCIL had issued a show cause notice to M/s ARG TECHNOCRATS as referred above at sr. no. 3 to clarify why an action should not be taken against you as per clause 1.13 of EOI in connection with submission of forged experience certificate by you for securing business with TCIL.

However, in spite of giving a reasonable opportunity by TCIL to you in this regard, you have submitted in your defence vide email at SI. No. 4. Hence, it is implied that the said document

was submitted with a malafide intention to secure the contract based on forged and fraudulent documents.

In view of the above, TCIL is left no other alternative but to take action as per the terms of Tender and Integrity Pact based on available records and documents with it.

After review the case under extant guidelines of TCIL and under clause No. 1.3 (Certification of Genuineness), No. 1.13 (Submission of Forged Documents) of the Tender Document and clause No. 1.11 of the integrity pact (Sanctions for Violations), it is hereby informed that:

M/s ARG TECHNOCRATS is disqualified from evaluation process in the said EOI and the Bid dated 17.02.2022 submitted against the said EOI stands rejected.

The competent authority of TCIL has imposed a ban on M/s ARG TECHNOCRATS as per clause 1.13 of tender under reference, for a period of two (02) years from the date of issue of banning order i.e., 30.05.2023, for doing any business across TCIL for all items/works/services.

Accordingly, M/s ARG TECHNOCRATS is hereby debarred/banned for participation in TCIL tender(s) / EOI(s) for a period of 2 years from date of issue of this order. Existing offers, if any, submitted by M/s ARG TECHNOCRATS will not be considered and shall be summarily rejected.

The above action is without prejudice to the rights of TCIL under the contract and /or law.
